STANDING REPORTS

Student Government Association – Submitted the following written report: Since the last meeting SGA celebrated Constitution Day by handing out preambles and cupcakes. They also teamed up with Valeria Haring and the Art Gallery to help promote our students awareness for registering to Vote. Tomorrow evening at the volleyball game, SGA will be handing out Breast Cancer Awareness shirts, "Rally Out Cancer". This Friday they will team up and help the Inclusion council with the 3on3 basketball tourney.

They also are looking forward to the student forum on the 15th, the blood drive on the 16th and homecoming on the 27th. It's a busy time, but that's ok!

Operational Staff – No update this month

<u>Professional Employees</u> – Dr. Sader reported that the faculty are fully engaged and ready to support the 5000 building discussions as well as the tax and tuition conversations that are happening in the community right now. He also reported that a lot of instructors have come to him with concerns about the low numbers of students in their classes and wanted to share their concerns.

<u>Board Finance Committee</u> – No meeting due to water being shut off, but there will be a budget work session following the regular meeting tonight.

<u>President's Report</u> – The college hosted Institutional Development Day (IDD) this morning prior to the water shut off. Dr. Krull presented her State of the College address and issued a call to action regarding the Andover remodel. The faculty and staff also had a keynote address from Alex Sheen, founder of because I said I would, about keeping promises and how individuals can make a difference. There were several breakout sessions that were well attended as well.

Dr. Krull also shared that the selection committee had decided to offer the Associate Vice President of Institutional Research & Effectiveness position to Dr. Esam Mohammad and he had accepted.

The vision task force was announced this week and the estimated timeline is to have a first meeting in late October or early November. They will start focus group meetings early in the new year and hope to offer their vision before time to approve the new tuition and fees structure as well as budget talks in the spring.

Chair Dreiling shared a brief report on the special board meeting that was held October 1, 2018 with Ray Connell, college legal counsel, Vince Haines, Gravity::Works. The meeting was called to discuss the special use permit and Plat process for the 5000 building remodel in Andover. They agreed that Butler of Andover needed to fit the vision established and to work alongside the City of Andover and the Andover School District to meet that vision. The board hopes for a win-win situation, but if that is not attainable the board is ready to look at other options.

<u>Education Facilities Authority Report</u> – Trustee Joyce shard that the board meetings this Thursday and is discussing the possibility of meeting more frequently while the stadium is in use. He also said the field had a lot of water on it, but there is a lot of water everywhere right now.
